

AGREEMENT

1
2 This agreement made this 3rd day of July, 1952, as
3 follows:

4 It is hereby known that Ray H. Smith, Jose Canez and Paul
5 Bell are partners in a mutual agreement made by the Parties
6 hereto, namely:

7 That in consideration of the discovery of certain mining
8 claims by Jose Canez and Paul Bell, it is agreed that Ray H.
9 Smith will furnish all monies necessary for the development of
10 these claims within his own discretion.

11 That for the consideration of the discovery of these claims
12 and the payment of expense monies for the development of these
13 claims, Ray H. Smith will have an eighty percent (80%) interest
14 in all operations mutually agreed upon by Ray H. Smith, Jose
15 Canez and Paul Bell.

16 That Paul Bell will be entitled to ten percent (10%) of
17 all net returns (smelter returns); that Jose Canez shall have
18 a ten percent (10%) interest in all net returns (smelter returns);
19 that Ray H. Smith shall have an eighty percent (80%) interest in
20 all net returns (smelter returns).

21 It is further agreed that this shall be a limited partnership
22 to the extent that only the assets of the partnership as described
23 in this agreement shall be subject to the debts and obligations
24 of the persons named in this agreement but there shall be no
25 personal liability of any Parties hereto other than the assets of
26 the partnership.

27 The Parties hereto will hereinafter designate the description
28 of the properties involved in this partnership. That it is
29 anticipated that the properties will be a portion of General
30 Electric Patented Tungsten property and about three (3) miles
31 in a northeasterly direction from the Figueroa Ranch House on the
32 west side of the Las Guijas Mountains starting in a northeasterly

1 direction approximately 750 feet from the northeast discovery
2 shaft; thence 300 feet to the southeast, being the southeast
3 corner and thence 1500 feet to a southwesterly direction and all
4 adjoining claims thereto being a re-discovery being made by
5 agents and employees of the Parties hereto; that these adjoining
6 claims are anticipated to be three, but in the event any other
7 operations are to be entered into, this agreement shall be binding
8 as to all operations relative to mining interests in the future.

9 That Walter M. Stevenson is hereby nominated as attorney for
10 this partnership and shall receive the sum of two and one-half
11 percent (2½%) of all smelter returns as a retainer for acting as
12 attorney.

13 This agreement is made upon the relocation of these claims,
14 the exact description of which is unknown and is to be added as
15 an addenda hereto.

SUPPLEMENTAL AGREEMENT

1 Referring to the original agreement and starting at lines
2 27 and 28, of page 1, of the original agreement, it is hereby
3 mutually agreed by the parties that the description of the property
4 presently involved in this partnership is as follows:

5 A mining claim situated and located in the
6 Las Guijas Mining District, in Pima County,
7 Arizona, about 3 miles in a Southwesterly
8 direction from the General Electric patented
9 tungstan property and about 3 miles in a
10 northeasterly direction from the Figueroa
11 ranch house on the west side of the Las
12 Guijas Mountains. This is a group of claims
13 known as Wolframite numbers 1, 2, 3, and 4, 5 & 6
14 And further the claim known as Wolframite.

15 It is agreed that Walter M. Stevenson is acting as attorney
16 for this partnership and in consideration of his being the
17 attorney for the partnership in all matters shall receive the sum
18 of 2½% of all smelter returns upon any and all mining operations

20 the event of sale of the claims herein before stated, that Walter
21 M. Stevenson shall receive the sum of 2½% of the net returns from
22 the sale.

23 It is further agreed by the parties hereto, to-wit: Jose
24 Caney, Paul Bell and Ray H. Smith, that in the event of sale of
25 the properties described in this partnership agreement, that the
26 parties shall share equally in the net returns after all expenses
27 involved in this mining operation or advancements made by Ray H.
28 Smith and expenses of sale have been deducted.
